We will never collect any unnecessary personal data from you and do not process your information in any way, other than already specified in this notice.

3.0 How We Use Your Personal Data (*Legal Basis for Processing*)

AW Rail Services Ltd takes your privacy very seriously and will never disclose, share or sell your data without your consent, unless required to do so by law. We only retain your data for as long as is necessary and for the purposes specified in this notice. Where you have consented to us providing you with promotional offers and marketing, you are free to withdraw consent at any time. The purposes and reasons for processing your personal data are detailed below: -



- We collect your personal data in the performance of a contract or to provide a service and to ensure that orders are completed and can be sent out to your preferred address
- We collect and store your personal data as part of our legal obligation for business accounting and tax purposes
- We collect and store your personal data as part of our legal obligation for the verification of right to work within the United Kingdom and for business accounting and tax purposes

4.0 Your Rights

You also have the right to request erasure of your personal data or to restrict processing in accordance with data protection laws, as well as to object to any direct marketing from us and to be informed about any automated decision-making that we use.

If we receive a request from you to exercise any of the above rights, we may ask you to verify your identity before acting on the relevant request; this is to ensure that your data is protected and kept secure.

5.0 Sharing and Disclosing Your Personal Information

We do not share or disclose any of your personal information without your consent, other than for the purposes specified in this notice or where there is a legal requirement AW Rail Services Ltd uses a third-party to provide the below services and business functions, however all processors acting on our behalf only process your data in accordance with instructions from us and comply fully with this privacy notice, the data protection laws and any other appropriate confidentiality and security measures.

- 5.1 Payroll as determined by AW Rail Services Ltd, which in this instance is managed by the company and therefore no individual detail of staff on the payroll is shared outside of the company

The company will provide a fully HMRC compliant contract of service capability for the payment to all operatives used by AW Rail Services Ltd. The information provided to this company is encrypted and managed electronically.

6.0 Safeguarding Measures

AW Rail Services Ltd takes your privacy seriously and we take every reasonable measure and precaution to protect and secure your personal data. We work hard to protect you and your information from unauthorised access, alteration, disclosure or destruction and have several layers of security measures in place, including: -

- Providing access to your data for those who have a right use it in the legal course of the business
- Ensure that all data is secured in a correct and proper manner which includes password protection of file access, encryption of sensitive data and selective access to files and folders held electronically on the server
- Access to areas where data is stored in locked filing cabinets – restricted to those who have a justifiable reason to gain access to that space

8.0 How Long We Keep Your Data

AW Rail Services Ltd only ever retains personal information for as long as is necessary and we have strict review and retention policies in place to meet these obligations. We are required under UK tax law to keep your basic personal data (*name, address, contact details*) for a minimum of 6 years after which time it will be destroyed.

9.0 Special Categories Data (if applicable)

Owing to the services that we offer, AW Rail Services Ltd sometimes need to request sensitive personal information from you to ensure that there is eligibility for an individual or individuals to be able to work within the United Kingdom, which will include gathering personal data in the form of passports, NI Numbers, NHS Numbers, Visa's and any supporting documents to confirm that there is a right to work and right to remain within the United Kingdom.

This data has to be obtained and retained for legal reasons and therefore we will collect sensitive personal data, but we will only request the information required for the specified purpose and always ask for your explicit consent through a signature. You can modify or remove consent at any time, which we will act on immediately, unless there is a legitimate interest or legal reason for not doing so.
